



KEY FIRST STEPS

Write a Business Plan

Define your long-range and short-range goals and objectives.

Develop a Financial Plan

Include projected profit and loss statements and cash flow statements for a period of at least two years.

Choose a Business Structure

LLC, corporation, sole proprietorship, etc. Seek legal advice or use workshop resources.

Obtain Licenses

- Minimal Activity License: For sales between \$3K–\$100K, \$15/year
- Standard Business License: For sales over \$100K, plus gross-receipts tax hendersontn.gov

Register & Learn

- Get assigned a City and County business license at City Hall & County Trustee's Office.
- Visit UT SBDC at 111 E Main St, Henderson or call (731) 989-5222
- Join the Chamber—access networking, leadership and youth programs

Locate Workspace

Explore downtown Henderson, parks and co-working spots designed for small businesses.

Consult Professionals for Advice

Speak to an attorney, an accountant, a banker and an insurance agent.

Whether you're launching a new venture from home or opening a storefront in downtown Henderson, starting a business in Chester County requires following a few essential steps. This guide outlines what you need to know to stay compliant and prepared.

Step

Establishing a Business Name and Address

Choose a business name and determine your physical or mailing address. If you are operating from home, specific zoning regulations apply (see "Home Occupations" in Step 7).



Step 2

Getting Your Licenses and Permits

All businesses operating within the City of Henderson and Chester County must obtain the proper business licenses.

State License Requirements:

Register with the Tennessee Department of Revenue (online at tn.gov/revenue) to collect and remit sales tax. You must register even if your business activity is minimal.

Business License Application Fees:

\$15.00 – City of Henderson

\$15.00 – Chester County

These fees are required whether you're operating from home, running a small retail shop or launching a larger business within city limits.

Types of Licenses:

Minimal Activity License – For businesses with annual gross sales under \$100,000. Apply at both the city and county offices; the fee is \$15 for each.

Standard Business License – Required for businesses with annual gross sales over \$100,000. Renew each year online through the TNTAP system. State tax is calculated based on gross receipts.

Step 3

Establishing Your Tax Accounts

Depending on your business type, you may need to establish the following tax accounts:

- Business Tax
- Sales Tax
- Alcohol Tax (if applicable)
- Franchise & Excise Tax (based on structure/type)

You'll register for these through the Tennessee Department of Revenue via the TNTAP system.

Step 4

Understanding Exemptions

Some businesses may qualify for exemptions from certain taxes:

Sales Tax Exemptions – For qualified nonprofit organizations or agricultural producers.

Franchise & Excise Tax Exemptions – For sole proprietors and some single-member LLCs.

Business Tax Exemptions – Certain professions or small operations may be exempt.

It's important to verify with the Department of Revenue or a business attorney to confirm eligibility.

Step 5

Registering with TNTAP

Use the Tennessee Taxpayer Access Point (tntap.tn.gov/eservices) to:

- Register your business
- File and pay taxes
- Apply for tax exemptions
- View your business tax history

Before registering, gather all required documentation, including your business structure, EIN (if applicable), estimated gross sales and ownership details.

Step 6

Tax Filing Deadlines

Staying on top of your tax responsibilities is crucial:

Business Tax – Due annually (based on fiscal year)

Sales Tax – Due monthly or quarterly (based on volume)

Franchise & Excise Tax – Due annually

License Renewals – Due yearly with the city, county and state (if applicable).

Set calendar reminders and utilize TNTAP for up-to-date filing schedules.

Step 7

Understanding Zoning and Permitted Uses

Before opening a business, it's important to determine whether your desired location is properly zoned for your business type. Zoning regulations help maintain the integrity of neighborhoods and commercial areas by ensuring appropriate land use.

City of Henderson Zoning Office: Contact the city planner or codes office to confirm zoning designations and restrictions.

Chester County Zoning/Planning Office: If operating outside city limits, check with the county government.

Zoning Map and Land Use Categories: Review available zoning maps and permitted use tables to verify your business type is allowed in the chosen location.

Home-Based Businesses: Must meet local performance standards and be clearly secondary to residential use.

For those operating a business from home:

Purpose: To allow residents to conduct small-scale businesses while maintaining the residential character of neighborhoods.

Performance Standards: Businesses must not generate excessive traffic, noise or signage.


Permitted Home Occupations: Examples include tutoring, consulting, online sales and craft making.

Prohibited Home Occupations: Mechanic shops, equipment rentals or any business that causes a neighborhood disruption.

Contact the City of Henderson Planning and Zoning office to confirm whether your business qualifies.

Step 8

Marketing and Promoting Your Business Locally

Once your business is up and running, visibility is key to growth. Here's how to connect with your audience in Chester County and beyond:

- Create a website, a domain name and Google business listing.
- Connect with the Southwest Tennessee Development District (regional and state).
- Engage in local career fairs.
- Join the Chamber of Commerce: Gain credibility, networking access and event promotion.
- Participate in Local Events: Farmers markets, craft fairs and Main Street activities offer in-person brand awareness.
- Social Media Presence: Establish active business pages on social media platforms to reach the community.
- Advertise Locally: Place ads or business cards in area publications like Discover Chester County, local radio stations or bulletin boards.
- Partner with Other Businesses: Cross-promote with complementary businesses to expand your audience.

Business Startup Checklist

Use this checklist to stay on track

- Choose and register a business name
- Confirm zoning and permitted use for location
- Apply for business licenses (city and county)
- Register with the TN Department of Revenue
- Set up sales tax accounts via TNTAP
- Open a business bank account
- Obtain all required permits (health, signage, etc.)
- Create a business plan
- Consult with a business attorney or CPA
- Purchase business insurance
- Set up branding, website and social media
- Network with the Chamber of Commerce and attend local events
- Keep track of tax deadlines and renewal dates

Frequently Asked Questions

Q: Do I need a business license even if I work from home?

A: Yes. Any business operating within the city or county—whether it's home-based, retail or service-oriented—must have a business license. Additional zoning or home occupation regulations may apply.

Q: What is the difference between a minimal activity license and a standard license?

A: If your business earns under \$100,000 in gross revenue annually, you qualify for a minimal activity license. If you exceed \$100,000, a standard business license is required and must be renewed through the TN Department of Revenue's TNTAP portal.

Q: Where do I pay my business license fee?

A: The \$15 business license fee is paid to both the City of Henderson and Chester County. Renewals are handled annually.

Q: How do I register for taxes in Tennessee?

A: Visit and use the checklist to register for all relevant state taxes. This may include sales tax, business tax, alcohol tax, etc.

Q: What permits do I need to serve food or beverages?

A: You will need a food service permit from the Chester County Health Department. Alcohol sales require state permits and additional oversight.

Q: Who can help me write a business plan or offer guidance?

A: The Tennessee Small Business Development Center (TSBDC) and SCORE West Tennessee offer free business mentoring and planning support.
